INTRODUCTION

"This Administration today, here and now, declares unconditional war on poverty in America." With this surprise announcement in his 1964 State of the Union address, President Lyndon Johnson committed the American people to their second great crusade of the 1960s. Just three years after President Kennedy established the national goal of getting men to the moon and back by the close of the decade, his recently inaugurated successor announced a less spectacular, but in many ways more fantastic, objective. What Lyndon Johnson sought was something that the Bible had said could not be done ("For ye have the poor always with you. . . .") and what no society committed to individual freedom had ever done: eliminate poverty. In the end, space proved more amenable to American technology than did want to American social engineering. The poor do indeed remain with us.

The history of the War on Poverty is a story of great promises, great expectations, great experiments, great excitement, and great disappointments. Only the end results were unworthy of the superlatives that marked everything else about this unprecedented effort. In other times, and under different circumstances, what the War on Poverty achieved--a significant reduction in the number of the nation's poor--might have been considered monumental, but in the 1960s and in the context of what the American people had been led to believe, the War on Poverty's accomplishments seemed inconsequential. With the perspective that the passing of decades provides, we can now begin to study and understand the antipoverty crusade in a way that those who knew it firsthand could not.

The White House Central Files will, for example, provide researchers with insight on how the President and his advisers attempted to deal with the two great bogies in American life raised by their War on Poverty--class and race. Nothing has so set the United States apart from other societies as our long-held beliefs that we had created a socioeconomic system that allowed everyone to realize his full potential, and that class distinctions, to the extent that they existed at all in our country, were no barrier to individual advancement. The presence, however, of severe and persistent pockets of poverty amidst the general affluence of Americans in the 1960s posed a serious challenge to the validity of those ideas and led to the formulation by academicians of the concept of a "culture of poverty." For millions of Americans, for reasons having little to do with their own personal deficiencies but a lot to do with the environment in which they lived, the American dream of success was more a bitter mirage than a realistic prospect. Armed with this idea, the Johnson administration marched into its War on Poverty under the banner of "economic opportunity." The poor in America would be helped not by handouts, but by a hand up: the chance to improve their condition by being well equipped to find and get decent paying jobs. Assisting the have-nots would not require any sacrifice by the haves; indeed, those already sharing in the nation's prosperity could count on both material and psychic rewards from the elevation of this underclass.

If the planners of the War on Poverty expected to defuse the explosive issue of redistributing income across class lines by meeting it head-on with the promise of fulfilling the American vision of a classless society, they were quite unprepared for the racial bombshells their programs set off. Although the State of the Union address in which President Johnson proclaimed his War on Poverty also contained a renewed plea for passage of the comprehensive civil rights legislation proposed by President Kennedy, neither the Chief Executive nor the nation saw the two issues as intimately related. If the people and their political leaders had become sensitized to the problem of poverty in the

early part of the 1960s, it was largely the product of exposure to the dismal conditions of poor whites in the mountains of Appalachia. Economists and sociologists were beginning to accumulate data revealing the prevalence of poverty in urban black ghettos, but the deprivation and desperation of those in such neighborhoods would become widely known only after the War on Poverty was underway. Within a very short time the antipoverty crusade became identified in the popular mind with poor blacks in big cities, which drastically changed the contours of political support for the War and forced the Johnson administration to re-examine some of its assumptions. Although they made the necessary adjustments in programs to reflect this shift in focus, strategists of the War on Poverty found themselves increasingly on the defensive as they fought on this new and treacherous terrain.

The War on Poverty was waged on a variety of fronts, and the many places in the White House Central Files where relevant materials are to be found reflect this bureaucratic maze. But if any single governmental unit acted as the headquarters for the crusade, then it was certainly the Office of Economic Opportunity (OEO), an independent agency created specifically for the War on Poverty and which reported directly to the President. Directed for the bulk of the Johnson years by the energetic Sargent Shriver, OEO was responsible for nearly all of the antipoverty crusade's best known and most controversial endeavors: Head Start, the Job Corps, Legal Services, and the Community Action Program (CAP). Because OEO was a brand new agency, the logical place for a researcher to begin studying the War on Poverty is **FG 11-15** (see Scope and Content Note for explanation), which provides a good overview of OEO's organization and staffing. On substantive issues, **WE 9** presents the most comprehensive treatment of poverty-related questions in the White House Central Files. The War on Poverty's progress and problems are detailed here; filed separately under the classification **WE 9-1** is material relating to Head Start, President Johnson's pet project. Although Congress had approved the War on Poverty with a minimum of investigation and debate in 1964, it still retained control of the purse strings and the ability to influence conduct of the War by additional legislation; these facts of political life are unveiled in **FI 4/FG 11-15**, **LE/FG 11-15**, and **LE/WE 9**. The **SP** files on the President's two major poverty speeches (1964, 1967) demonstrate how--after three years of conflict, especially over CAP and its hotly disputed attempts to involve the poor in decision making (the "maximum feasible participation" rule)--the White House, by now bogged down in a more literal war on the other side of the globe, was losing its appetite for further social experimentation.

In 1966, while its influence with Congress was still great, the Johnson administration had pushed through the Model Cities Program. Building upon long-established public housing and urban renewal efforts, Model Cities attempted to integrate physical redevelopment of inner city neighborhoods with a wide range of social services and job opportunities. Although administered by the Department of Housing and Urban Development, rather than OEO, Model Cities reflected the growing appreciation of the urban character of the nation's poor population and was generally perceived as part of the War on Poverty. The operations of Model Cities can be studied in the **LG** files.

Two further aspects of the War on Poverty, neither of which enjoyed the President's enthusiastic support, are covered by the material in this collection. For all of this nation's agricultural abundance, the specter of hunger had never disappeared from the land; the closing years of the Johnson administration witnessed both the wider public knowledge of this tragic problem and the vigorous efforts to solve it. The divided mind of the White House on the value and wisdom of food stamps is revealed in the **AG**, **BE**, and **LE/BE** files. If giving food to people seemed to be a handout, at odds with the policy of supplying people with a hand up, the same criticism could be directed at proposals for a program of income maintenance. The 1960s saw the beginnings of serious debate on the virtues of a federally guaranteed minimum income. The President rejected the idea out of hand, but it would not go away. Ironically, a major source of support for the concept was the Office of Equal Opportunity, which had come to the conclusion that if poverty was to be abolished in America, income maintenance of some form had to be provided. This controversy can be examined in the **WE 9** files, as well as in **WE 6**, **LE/WE 6**, and **FG 11-3** (the Council of Economic Advisers).

When Lyndon Johnson left the White House in January 1969, his War on Poverty had not been won; poverty had not disappeared from American life. Yet if the victory promised by Johnson had eluded him and the nation, the President could take solace in the fact that after five years of struggle, almost no aspect of domestic policy could be discussed without asking the question: "What does it do

for the poor?" The documents presented here will help researchers understand both why the poor remain with us and why we remain concerned about them.

[*N.B.* A detailed account of the selected subject categories included in this publication is contained in the Scope and Content Note that follows.]

SCOPE AND CONTENT NOTE

Part I of the War on Poverty, 1964-1968, is drawn from one of the most voluminous record groups at the Lyndon B. Johnson Library: the White House Central Files. This microfilm publication from University Publications of America (UPA) focuses on four major aspects of the War on Poverty as reflected in those files: Office of Economic Opportunity; Model Cities; the Food Stamps Program; and Income Maintenance (Welfare Reform).

The White House Central Files were designed as a reference service for the President and his staff to document White House activities and consist of four major components: the Subject File, the Name File, the Chronological File, and the Confidential File. The Name File is essentially an index to the Subject File. The Chronological File primarily contains copies of outgoing correspondence, while the Confidential File contains material that was regarded as security or administratively classified. This publication utilizes the Subject File and the Confidential File.

Subject File

The Subject File contains correspondence and reports pertaining to the functions and operations of the White House, the federal government, and state, local, and foreign governments. Correspondence and reports from private companies, organizations, and individuals are also filed here. Material is divided into two categories: "Executive" and "General."

The "Executive" material has correspondence and reports of particular importance due either to their source or content, and generally includes documents received from executive agencies and departments, members of Congress, and other prominent correspondents. It also includes copies of outgoing correspondence and memoranda, as well as other documents that were acted on or brought to the attention of the President or a designated White House official.

The "General" material contains correspondence and documents from the general public and other sources that, while noteworthy because it is addressed to the President, is not as important as the "Executive" material from the viewpoint of level of handling or subject matter. This material generally includes all correspondence and documents that are not classified in the "Executive" category and may include routine communications from members of Congress or memoranda exchanged among lower echelon officials.

The Subject File of the White House Central Files at the LBJ Library consists of 62 subject categories. As noted previously, this publication focuses on four of these categories.

Listed below are the subject categories that are included in this publication, with a brief description of the contents of each.

I. Office of Economic Opportunity

The subject categories FG 11-15 through FG 11-15-2/A contain material from, to, or about the organization and activities of the Office of Economic Opportunity and its appendages, Job Corps and the National Advisory Council on Economic Opportunity. Subject categories FI 4/FG 11-15 and FI 4/FG 11-15-1 contain material related to superintending and managing the federal budget, appropriations, and supplemental appropriations for federal departments, agencies, and programs, such as the Office of Economic Opportunity and the Job Corps Program. Unless otherwise noted, the "Executive" material in this and the following subject categories has been filmed in its entirety.

The subject categories LE/FG 11-15 and LE/WE 9 contain material pertinent to the Great Society legislation. Included are antipoverty legislation, the Poverty Bill, the OEO Bill, the Community Development District Bill of 1966, and the Neighborhood Development Corporation Assistance Bill of 1967, among others.

The Speeches subject categories SP 2-3/1964/WE and SP 2-3/1967/WE 9 contain press copies of special messages, background material, comments, and press releases.

Welfare subject categories WE 9 and WE 9-1 have material pertaining to the formulation and conduct of the Poverty Program. Statistical information, program descriptions, budget matters, local/state/federal relations in the administration of poverty programs, ideas and criticism, integration of programs, and attempts to spin-off Project Head Start from the OEO are included.

II. Model Cities

In this microfilm publication, the subject category FA 4 (Federal Aid--Housing) contains only material pertaining to federal financial aid to state and local governments for housing programs--the Rent Supplement Program, Model Cities, and the Demonstration Cities Bill. The subject category FG 170 (Federal Government--Department of Housing and Urban Development) contains material from, to, or about the organization and activities of the department, and selections of "Executive" file material were limited to material on the Model Cities Program.

Housing subject categories HS 2 and HS 3 contain material pertaining to programs developed for the prevention and elimination of slum and blight conditions. Material on the Public Housing Program includes efforts made to provide adequate housing for all Americans, financing of programs, "turnkey" projects, and the Rent Supplement Program. Urban Renewal-Slum Clearance material includes plans for slum clearance with efforts to involve the private sector, progress in meeting the needs of tenement dwellers, and ideas on urban renewal problems. "Executive" material selections have been limited to material on the Model Cities Program, the Rent Supplement Program, the Housing and Urban Development Act of 1968, and related housing programs.

The subject category LG (Local Government) contains material that reflects federal contact and concern with local governments. Through correspondence, memoranda, reports, resolutions, proposals, and speeches, many issues are covered, the urban crisis in particular is recognized, and administration efforts to cure some of its ills are shown through legislation, reports, and meetings. Specifically, this subject category contains reports and memoranda to the President from the Vice-President, in his role as the President's liaison with local governments. There is considerable material on the Model Cities Program and related programs such as the Housing and Urban Development Act, the Rent Supplements Program, urban renewal, federal aid to cities, and the Neighborhood Centers Program. Selections of "Executive" material have been limited to materials on the Model Cities Program, the Rent Supplements Program, the Demonstration Cities Bill, and related programs.

The subject category SP 2-3/1967/WE 9 (Speeches--Special Messages/1967/Welfare--Poverty Program) contains press copies of special messages, background material, comments, and press releases, with the "Executive" material filmed in its entirety.

III. Food Stamps Program

Agriculture subject category AG 7 contains material on food surplus products and distribution programs, including the Food Stamps Program, with filmed "Executive" material being limited to that on the Food Stamps Program. The subject category BE 5-5/AG 7 (Business-Economics--Recessions-Depressions/Agriculture--Surplus Products) also contains material primarily on the Food Stamps Program, and "Executive" material was filmed in its entirety.

The subject category LE/BE 5-5/AG 7 (Legislation/Business-Economics--Recessions-Depressions/Agriculture--Surplus Products) contains material on Food Stamps legislation and other food programs. The "Executive" material in this subject category has not been filmed in its entirety, with selections limited to material on the Food Stamps Program and the Food Stamps Act of 1964.

The subject category WE (Welfare) contains material on the improvement of the welfare of the people and developing community welfare services, national goals, and social trends, such as Income Maintenance (Welfare Reform) and the Food Stamps Program. "Executive" material selections have been limited to material on the Food Stamps Program and Income Maintenance (Welfare Reform).

IV. Income Maintenance (Welfare Reform)

The subject category FG 11-3 (Federal Government--Council of Economic Advisers) contains material from, to, or about the organization and activities of the Council of Economic Advisers. "Executive" material selections were limited to material on Income Maintenance and related welfare reform programs. Legislation/Welfare subject category LE/WE 6 has material pertaining to amending the Social Security Act, work incentive programs, aid to families with dependent children, social manpower legislation, and the appointment of a Commission on Income Maintenance. "Executive" material selections have been limited to materials on Income Maintenance and related welfare reform programs.

The subject categories WE (Welfare) and WE 6 (Welfare--Social Security) contain materials pertaining to the improvement of the welfare of the people and on the issue of social security reforms, costs and financing, and income maintenance. "Executive" material selections have been limited to materials on Income Maintenance and related welfare reform programs.

Confidential File

The Confidential File at the LBJ Library consists of the same 62 subject categories as used in the Subject File. The materials in the Confidential File were segregated from the Subject File due to their security-classified or administratively classified status. Again, the four major aspects of the War on Poverty are emphasized. Many of the subject categories used here are also the same as in the Subject Files; however, the Confidential File material is not segregated into "Executive" and "General" categories and, unless noted by a description in brackets following the category name, material in each category was filmed in its entirety.

The Model Cities subject category LE/HS Confidential File (Legislation/Housing) has not been described in the Subject File portion of this Scope and Content Note. Most of the material in this subject category pertains to the Housing and Urban Development Act of 1968, and selections have been limited to material on the 1968 Act and the Model Cities Program.

REEL INDEX

Entries in this index refer to specific folders within the White House Central File system. These folders are typically a chronological grouping of documents from the Executive Departments, Congress, and private individuals and organizations. In the interest of accessing material within folders this index denotes the major substantive issues, reports, or key policy formulations under the category of *Major Subjects*. Individuals who contributed significant correspondence, wrote particularly insightful memoranda, or authored reports within folders are denoted under the category of *Principal Correspondents*. As the President was integral to virtually all decisions and proceedings, there are no listings for President Johnson.
